- Ensure, based on pilot & all other relevant information, daily problem analysis & problem solving;
- Ensure briefing & debriefing of pilots and Chief Engineer;
- Ensure that PRF (preflight check) is performed;
- Ensure, in cooperation with NHV Supply Chain, Store & support services that the necessary maintenance
 material & spare parts are present on site at the planned moment: material in service car, consumables,
 limited service stock, work material, material needed for normal day-to-day line maintenance, exceptional
 material supplied for exceptional line maintenance or small repair tasks;
- Report daily on the maintenance situation to the Chief Engineer.

- Assist with the technical preparation of flights.
- · Carrying out HHO flight duties, in accordance with NHV's SOP's related to the allocated helicopter type.
